



**Case Study** 

## \$178K in plan savings and improved quality of care

67-year-old female with MSS (microsatellite stable), BRCA negative, metastatic pancreatic cancer with disease progression to the liver following surgery and adjuvant gemcitabine plus capecitabine chemotherapy. ECOG=1.

#### **Original Request**

- Opdivo (nivolumab) + Yervoy (ipilimumab)
- 3-Month Cost = \$178,932

#### Clinical Evidence

- Drugs are Off-label, Off-evidence
- Patient is not MSI-High so pembrolizumab is not an option
- Clinical trial enrollment is recommended; Standard of care chemotherapy options remained

#### **OncoHealth Recommendation**

- Oncologist to oncologist peer-to-peer review discussion regarding consideration of standard of care FOLFIRINOX (5-FU, Leucovorin, Oxaliplatin, Irinotecan) as an alternative
- FOLFIRINOX has a survival advantage in this setting OR clinical trial

#### Result

- Treating oncologist agreed to change therapy to FOLFIRINOX
- Patient received standard of care regimen with proven efficacy; improved quality of care
- 3-Month estimated savings to Health Plan = \$177,943




